Section 14-5-1-6 ROA 1994, is amended to read: 8 **"§ 14-5-1-6** BASIS FOR ESTABLISHING AREAS OF SPECIAL FLOOD 9 HAZARD; FLOOD INSURANCE STUDY ADOPTED BY REFERENCE. 10 (A) The areas of special flood hazard are identified by the Federal Emergency Management Agency in a scientific and engineering report entitled 11 Bracketed/Strikethrough Material] - Deletion Bracketed/Underscored Material] - New 12 The Flood Insurance Study for Bernalillo County, New Mexico and 13 Incorporated Areas, dated August 16, 2012, with accompanying flood 14 insurance rate maps and flood boundary-floodway maps and any revisions 15 thereto. 16 (B) Said study, maps and revisions identified in division (A) above are 17 hereby adopted by reference and declared to be a part of §§ 14-5-1-1 et seq." 18 SEVERABILITY CLAUSE. If any section, paragraph, sentence, Section 2. 19 clause, word or phrase of this ordinance is for any reason held to be invalid or 20 unenforceable by any court of competent jurisdiction, such decision shall not 21 affect the validity of the remaining provisions of this ordinance. The Council 22 hereby declares that it would have passed this ordinance and each Section, 23 paragraph, sentence, clause, word or phrase thereof irrespective of any

provision being declared unconstitutional or otherwise invalid.
