ORDINANCE NO. 013-23

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH **SOUTHEASTERN EQUIPMENT CO. INC.** TO PURCHASE A **2023 CASE 621G XR WHEEL LOADER** AND DECLARING AN EMERGENCY

WHEREAS, the Service Director recommended the purchase of a **2023 Case 621G XR Wheel Loader**, through **Sourcewell Cooperative Purchasing** for the efficient operation of the department, and

WHEREAS, the current 2010 Case Loader will be traded in or sold.

WHEREAS, Southeastern Equipment provided the lowest price for said equipment through **Sourcewell Cooperative Purchasing Contract # 032515-CNH**

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Bedford, County of Cuyahoga, and the State of Ohio:

Section 1. Council for the City of Bedford hereby authorizes the City Manager to enter into a contract with **Southeastern Equipment Co. Inc.**, 1500 Industrial Parkway, Brunswick, Ohio 44212, to purchase **one 2023 Case 621G XR Wheel Loader** through **Sourcewell Cooperative Purchasing** process for the total amount of **Two Hundred Seventeen Thousand Three Hundred Eleven Dollars and Sixty Cents (\$217,311.60)**.

Section 2. The Council of the City of Bedford hereby authorizes the Finance Director to appropriate and pay the sum of **Two Hundred Seventeen Thousand Three Hundred Eleven Dollars and Sixty Cents (\$217,311.60)** from **Fund No. 500-9511-00-5-9750-0** through the **Sourcewell Cooperative Purchasing** process from **Southeastern Equipment** for a **2023 Wheel Loader**.

Section 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

This Ordinance is hereby determined to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the City of Bedford for the efficient operation of the department.

WHEREFORE, this Ordinance shall take effect and be in force from and after the earliest date allowed by law.
