ORDINANCE NO. 017-24

AN ORDINANCE AMENDING **ORDINANCE NO. 9365-16** CHAPTER 1103 ENTITLED “**MUNICIPAL SWIMMING POOL**” SPECIFICALLY **SECTION 1103.01** ENTITLED “**FEES**” OF THE CODIFIED ORDINANCES OF THE CITY OF BEDFORD AND DECLARING AN EMERGENCY

WHEREAS, Council for the City of Bedford has determined that fees associated with usage of the Bedford Municipal Pool need to be adjusted to better recover the real costs of pool operations.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Bedford, County of Cuyahoga, and the State of Ohio:

Section 1. That Chapter 1103 Titled “Municipal Swimming Pool” specifically Section 1103.11 entitled “Fees” to read as follows:

Family of 4	\$100	
*each additional person	\$15	
Individual	\$40	
Seniors (60+)	\$20	
Daily Resident	\$5	
Daily Non-Resident (Must be with resident)	\$10	
Learn to Swim	\$40	\$60
Learn to Swim (Family 3+ children)	\$90	\$140
Swim Team	\$40	\$60
Swim Team (Family 3+ children)	\$90	\$140

All programming for the Parks & Recreation Department will be set forth by the Recreation Director and/or the appropriate manager and shall be subject to review, change, addition and elimination of the Director, City Manager and Finance Director’s discretion.

In addition, fees for the municipal swimming pool and programs associated with the municipal swimming pool shall be set forth by the Recreation Director and/or the appropriate manager and shall be subject to change as the City Manager or Finance Director in accordance with the annual budgetary appropriations authorized by City Council for the Parks & Recreation Department.

Section 2. This Ordinance supersedes and repeals any prior ordinances that contain provisions that conflict with the provisions herein.

Section 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the public peace, health, safety, and welfare of the City of Bedford and for the further reason that these fee adjustments are necessary to better assist the City of Bedford in recovering the costs of pool operations.

WHEREAS, this Ordinance shall be in full force and effect immediately upon its passage.
