ORDINANCE NO. 019-23

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH **BEST EQUIPMENT CO. INC.** FOR THE PURCHASE OF A ENVROSIGHT ROVVER X BASIC SYSTEM WITH AN INTEGRATED LIFT AND DECLARING AN EMERGENCY

WHEREAS, the Service Director recommends the purchase of an Envrosight Rovver X Basic system w/ integrated lift, through Sourcewell Cooperative Purchasing, which will give the department the ability to inspect mainline pipes and culverts, and

WHEREAS, Best Equipment Co. Inc. provided the lowest price for said equipment through Sourcewell Cooperative Purchasing Contract # 120721-EVS

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Bedford, County of Cuyahoga, and the State of Ohio:

Section 1. Council for the City of Bedford hereby authorizes the City Manager to enter into a contract with Best Equipment Co. Inc., 12620 York Delta Dr., N., Royalton, OH 44133, to purchase one Envrosight Rovver X Basic system w/ integrated lift for the total amount of **\$108,905.60.**

Section 2. The Council of the City of Bedford hereby authorizes the Finance Director to appropriate and pay the sum of **One Hundred and Eight thousand Nine hundred and Five dollars and Sixty cents (\$108,905.60)** from **Fund No. 501** to **Best Equipment Co. Inc.**

Section 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the public peace, health, safety, and welfare of the City of Bedford, Ohio, and to give the department the ability to inspect all of the mainline pipes and culverts in the community.

WHEREFORE, this Ordinance shall take effect and be in force from and after the earliest date allowed by law.
