ORDINANCE NO. 027-23

AN ORDINANCE AMENDING ORDINANCE 9862-21 AUTHORIZING THE PURCHASE OF ONE CONCORD NOREASTER MPS-1055C-S HEAVY-DUTY CHASSIS MOUNTED MULTI-PURPOSE GRANULAR MATERIALS SPREADER AND A HEAVY-DUTY MUNICIPAL POWER ANGLING SNOWPLOW, THROUGH THE STATE OF OHIO TERM SCHEDULE CONTRACT NUMBER 800860: INDEX NUMBER ST515 AND DECLARING AN EMERGENCY

WHEREAS, the City of Bedford is a member of the State of Ohio Cooperative Purchasing Program pursuant to Ohio Revised Code Section 5513.01, and

WHEREAS, in Ordinance No. 9862-21 the City wished to purchase One (1) 2022 Concord Noreaster MPS-1055C-S heavy-duty chassis-mounted multi-purpose granular materials spreader and a heavy-duty municipal power angling snowplow through the State of Ohio Cooperative Purchasing Program, and

WHEREAS, due to supply chain issues in the market these pieces of equipment were not readily available as in the past and the price has increased as a result.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Bedford, County of Cuyahoga and the State of Ohio.

Section 1. The City Manager is hereby authorized to purchase one (1) Concord Noreaster MPS-1055C-S heavy-duty chassis-mounted multi-purpose granular materials spreader and a heavy-duty municipal power angling snowplow through the State of Ohio Cooperative Purchasing Program from Concord Road Equipment, 348 Chester Street, Painesville, Ohio 44077, for **Eighty-Eight Thousand One Hundred Sixty-Four Dollars and Eighty-Two Cents (\$88,164.82)** from **Water Fund No. 500** and the Finance Director is hereby authorized to appropriate and pay said sum. Ordinance No. 9862-21 is hereby amended accordingly.

Section 2. This Council finds and determines that all formal action of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public and in compliance with the law.

Section 3. This Ordinance is declared to be an emergency measure immediately necessary for the public peace, health, safety and welfare and for the further reason that is necessary to purchase this to replace this equipment at a reduced price through the program as soon as possible.

WHEREFORE, this Ordinance shall take effect and be in force from and after the earliest date allowed by law.
