ORDINANCE NO. 10,009-22

AN ORDINANCE AUTHORIZING THE APPROVAL OF ENGINEERING FEES TO **GPD GROUP** FOR ITS SERVICES REGARDING DESIGN AND CONSTRUCTION ADMINISTRATION COSTS ASSOCIATED WITH THE **ENNIS AND HARRIMAN WATERLINE IMPROVEMENT** IN THE CITY OF BEDFORD AND DECLARING AN EMERGENCY

WHEREAS, this project is known as the design and construction administration for the Ennis and Harriman Waterline Improvement pursuant to the terms contained in the July 26, 2022 letter from the City Engineer attached hereto and incorporated by reference, and

WHEREAS, the Administration authorized GPD Group to perform Engineering Design and to determine Construction Administration costs for the improvements.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Bedford, County of Cuyahoga, and the State of Ohio:

Section 1. The Council for the City of Bedford authorizes the City Manager to pay the invoices to GPD Group for design and construction costs for the improvements.

Section 2. The Finance Director of the City of Bedford is hereby authorized to appropriate and pay a sum not to exceed **Thirty-Seven Thousand Dollars and Zero Cents (\$37,000.00)** for design fees, and **Thirty-Five Thousand Dollars and Zero Cents (\$35,000.00)** for construction administrative costs, with **Sixty-One Thousand Nine Hundred Twenty Dollars and Zero Cents (\$61,920.00)** from **Fund No. 500-9512-00-5-9635-0** and **Ten Thousand Eighty Dollars and Zero Cents (\$10,080.00)** from **Fund No. 403-6402-00-5-8960-0** to GPD Group.

Section 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the public peace, health, safety, and welfare of the City of Bedford and to pay the invoices timely.

WHEREFORE, this Ordinance shall be in full force and effect immediately upon its passage.
