## ORDINANCE NO. 9945-22

## AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH **JAY AUTO GROUP** FOR THE PURCHASE OF ONE (1) 2022 GMC SIERRA 2500HD (TC20903) <sup>3</sup>/<sub>4</sub> TON 2WD PICKUP TRUCK REGULAR CAB AND DECLARING AN EMERGENCY

WHEREAS, the Service Director recommended the purchase of a 2022 GMC Sierra 2500HD 2WD Regular Cab Pickup Truck to replace a 2005 truck for the efficient operation of the department, and

WHEREAS, Jay Auto Group provided the lowest price for said purchase.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Bedford, County of Cuyahoga, and the State of Ohio:

<u>Section 1.</u> The Council for the City of Bedford hereby authorizes the City Manager to enter into a contract with Jay Auto Group, 18800 Rockside Road, Bedford, Ohio 44146, to purchase one 2022 GMC Sierra 2500HD 2WD Regular Cab Pickup Truck for the total amount of **Thirty Thousand Four Hundred Seventy-Two Dollars and Zero Cents (\$30,472.00).** 

<u>Section 2.</u> The Council of the City of Bedford hereby authorizes the Finance Director to appropriate and pay the sum of **Thirty Thousand Four Hundred Seventy-Two Dollars and Zero Cents (\$30,472.00)** from **Fund No. 500-9511-00-5-9750-0** to Jay Auto Group for said purchase.

Section 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

<u>Section 4.</u> This Ordinance is hereby determined to be an emergency measure necessary for the preservation of the public peace, health, safety, and welfare of the City of Bedford for the efficient operation of the department and to avoid any price increase.

WHEREFORE, this Ordinance shall take effect and be in force from and after the earliest date allowed by law.
