## ORDINANCE NO. 9968-22

AN ORDINANCE AUTHORIZING THE APPROVAL OF ENGINEERING FEES TO **GPD GROUP** FOR ITS SERVICES REGARDING DESIGN FEES, CONSTRUCTION ADMINISTRATION AND INSPECTION COSTS ASSOCIATED WITH THE **BROADWAY WATERLINE IMPROVEMENTS PROJECT** IN THE CITY OF BEDFORD AND DECLARING AN EMERGENCY

WHEREAS, this project will consist of waterline repairs and replacement in the downtown area pursuant to the contract with Fabrizi Trucking and Paving Inc. authorized by Ordinance No. 9959-22, and

WHEREAS, the Administration recommends GPD Group to perform said services for the project.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Bedford, County of Cuyahoga, and the State of Ohio:

Section 1. Council for the City of Bedford authorizes the City Manager to contract with GPD Group for Engineering Design Fees, Construction Administration and Inspection Costs for said project as described in the March 29, 2022, Award Recommendation Letter for the project.

Section 2. The Finance Director of the City of Bedford is hereby authorized to appropriate and pay a sum not to exceed Sixty-Nine Thousand Five Hundred Dollars and Zero Cents (\$69,500.00) for design fees, and Eighty Thousand One Hundred Forty-Five Dollars and Zero Cents (\$80,145.00) for construction administration and inspection costs, with Forty-Nine Thousand Nine Hundred Eighty-Nine Dollars and Nineteen Cents (\$49,989.19) from Fund No. 403-6170-00-5-9110-0, Ninety-Four Thousand Twenty-One Dollars and Thirty-Nine Cents (\$94,021.39) from Fund No. 500-9512-00-5-9633-0, and Five Thousand Six Hundred Thirty-Four Dollars and Forty-Two Cents (\$5,634.42) from Fund No. 501-9522-00-5-8008-0 to GPD Group for said Design Costs.

Section 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

<u>Section 4.</u> This Ordinance is hereby declared to be an emergency measure immediately necessary for the public peace, health, safety, and welfare of the City of Bedford and for the further the City desires to immediately authorize said fees to expedite the project.

WHEREFORE, this Ordinance shall be in full force and effect immediately upon its passage.
