ORDINANCE NO. 9977-22

AN ORDINANCE AMENDING ORDINANCE NO. 9275-15 AUTHORIZING AND DIRECTING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH **KIMBLE** BEING THE LOWEST AND BEST BIDDER, AND DECLARING AN EMERGENCY

WHEREAS, the City Manager has heretofore been authorized and directed by the Council of the City of Bedford, the City of Bedford Heights, the Village of Orange and the Village of Walton Hills pursuant to a Joint Agreement to form a Solid Waste Consortium (“Consortium”) which will provide significant savings for each community, to advertise for bids for a **five (5) year contract for the collection and disposal of garbage/refuse collection and recycling with two one year options to extend**, and

WHEREAS, the City Manager has caused said advertisement to be made, and has received, opened, and tabulated bids and reported the same to Council in order that the Council may determine the lowest and best bidder, as provided in the Charter and the agreement of said Consortium, and

WHEREAS, the Consortium recommends Kimble to provide said services.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Bedford, County of Cuyahoga, and the State of Ohio:

Section 1. That the Council, upon the recommendation of the Consortium, hereby finds and determines that said advertisement was duly made according to law, that bids have been received, opened and tabulated, and reported to the Council, and that the Council after due consideration thereof does hereby find and determine the bid of **Kimble** to be the lowest and best bid submitted, that the said bid is hereby accepted and that the City Manager is hereby authorized and directed to enter into a **five (5) year contract** with two one year contracts to extend in an amount of **approximately Five Million Eighty-Two Thousand One Hundred and Fifteen Dollars and Eighty-Eight Cents (\$5,082,115.88)**; and that the said sum herewith is appropriated and ordered to be paid out of **Fund No. 221-5170-00-5-5900-0** or a fund designated by the Finance Director as required by the Ohio Revised Code and or prepared by the State Auditor, conditioned on the passage by all communities in the Consortium.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this legislation were adopted in an open meeting of this Council, and all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Revised Code Section 121.22.

Section 3. This ordinance is hereby declared to be an emergency measure immediately necessary for the public peace, health, safety, and welfare and for the further reason that it is immediately necessary for the Council to determine the lowest, responsive and responsible bidder for the foregoing items, to appropriate funds, therefore, and for the City to enter into a

contract with the successful bidder at the earliest time due to the current contract **expiring July 31, 2022.**

WHEREFORE, this Ordinance shall take effect and be in force from and after the earliest date permitted by law.
