ORDINANCE NO. 9978-22

AN ORDINANCE TO LEVY ASSESSMENTS FOR THE EXPENSE OF GARBAGE/REFUSE COLLECTION, RECYCLING, AND DISPOSAL WITHIN THE CITY OF BEDFORD, OHIO DURING TAX YEARS 2022, 2023, AND 2024 AND COLLECTED IN 2023, 2024, AND 2025, RESPECTIVELY AND DECLARING AN EMERGENCY

WHEREAS, the City Manager was authorized to enter a contract with Kimble to provide solid waste services pursuant to Ordinance No. 9977-22 for the reasons stated therein, and

WHEREAS, the City assesses the cost for said services to ensure payment pursuant to the terms of the contract as authorized by the Ohio Revised Code.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Bedford, County of Cuyahoga, and the State of Ohio:

Section 1. That the cost of **garbage/refuse collection, recycling, and disposal**, in the City of Bedford, **as per addendum attached hereto**, which assessments together with the description of said households are now on file in the office of the Clerk of Council, and which assessments are not in excess of the special benefits to said property, and is not in excess of any statutory limitation, is hereby approved for the tax years **2022, 2023, and 2024 collected in 2023, 2024, and 2025, respectively**, pursuant to Ohio Revised Code Section 701.10.

Section 2. That the total cost of the above assessments shall be payable in cash within thirty (30) days from and after the passage of this ordinance. All cash payments shall be made to the City of Bedford, c/o the Director of Finance. The assessments remaining unpaid at the expiration of said thirty (30) day period shall be certified to the County Auditor by the Clerk of Council, as provided by law, to be placed on the tax duplicate to be assessed and collected on the next tax collection.

Section 3. This Ordinance is hereby determined to be an emergency measure necessary for the preservation of the public peace, health, safety, and welfare of the City of Bedford, and for the further reason that it is necessary to pass this ordinance at the earliest time to place these assessments on the tax duplicate to be assessed and collected on the next tax collection.

WHEREFORE, this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
