A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY FISCAL OFFICER AND DECLARING AN EMERGENCY

WHEREAS, this Council in accordance with the provisions of the law has previously adopted a tax budget for the succeeding fiscal year commencing on January 1, 2022 for collection in 2023.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Bedford, Cuyahoga County, Ohio, that the amounts and rates as determined by the Budget Commission in its certification be and the same are hereby accepted and be it further RESOLVED that there be and is hereby levied on the tax duplicate of said City the rate of each tax necessary to be levied without the twenty-one-point seven mill limitation as follows:
