AN ORDINANCE AMENDING CHAPTER 15, BUILDING AND STRUCTURES AS IT RELATES TO THE PERMITTING FEES

The City Council of the City of Bloomington hereby ordains: That Chapter 15, Article IX, of the City Code is hereby amended by deleting those words that are in [strikethrough] font and adding those words that are <u>underlined</u>, to read as follows:

(a) *Building permit fees.* A fee for each building permit shall be paid to the Building Official as set forth below:
