

5	EXHIBIT I FOR THE PROPERTY IDENTIFIED AS ASSESSOR'S PARCEL NO. 002-180-200 (CITY OF CHICO)		
6	BE IT ORDAINED by the Council of the City of Chico that:		
7	Section 1. The zoning map shall correctly reflect the R4 (High Density Residential)		
8	zoning classification on Assessor's Parcel Nos. 002-180-200 as depicted on Exhibit I.		
9	Section 2. The Planning Commission previously considered the General Plan amendment		
10	(GPA 19-03), staff report, and comments at a duly noticed public hearing held on June 5, 2019,		
11	and adopted Planning Commission Resolution 19-08, recommending City Council approval of		
12	the requested General Plan amendment.		
13	Section 3. The City Council previously considered General Plan amendment (GPA 19-		
14	03), staff report, and comments at a duly noticed public hearing on August 6, 2019, and adopted		
15	Ordinance No. 2534.		
16	Section 4. The previous noticing, staff report, and zone change for the property was for		
17	R4 (High Density Residential) but the wrong map color was included on Exhibit I.		
18	Section 5. The correct map color and Exhibit I is attached hereto; and		
19	Section 6. This ordinance shall become effective 30 days following the date of its		
20	adoption.
