ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CHICO AMENDING THE PREZONING OF PROPERTIES WITHIN THE BELL-MUIR SPECIAL PLANNING AREA FROM SPA (SPECIAL PLANNING AREA) TO R1 (LOW DENSITY RESIDENTIAL) (RZ 24-02)

WHEREAS, the Council has received an application to amend the City's pre-rezoning of certain properties located within the City of Chico's Sphere of Influence in the County of Butte, State of California, generally described as Assessor's Parcel Numbers 042-020-009 and 042-020-105, from SPA (Special Planning Area) to R1 (Low Density Residential) to accommodate a proposed tentative subdivision map within the Bell-Muir Special Planning Area (Bell-Muir SPA); and

WHEREAS, the Council desires to expand the amendment of the City's pre-zoning to include all of the other properties located within the Bell-Muir SPA which are currently pre-zoned SPA, amending the City's pre-zoning to R1 (Low Density Residential) as depicted on the plat attached hereto as Exhibit I entitled Rezone 24-02 (Bell Muir SPA Dissolution); and

WHEREAS, the proposed rezone is accompanied by a related application to amend the General Plan (GPA 24-02) and a related application to subdivide and develop certain properties generally described as Assessor's Parcel Numbers 042-020-009 and 042-020-105 consistent with the proposed rezone (Autumn Leaf Estates Vesting Tentative Subdivision Map, SUB 24-01); and

WHEREAS, in accordance with Section 19.06.030 of the Chico Municipal Code (CMC), the City of Chico Planning Commission, after having considered the proposed rezone at a public hearing, duly noticed and held in a manner required by law, has submitted to this Council its recommendation to approve such rezone; and

WHEREAS, this Council, having reviewed the staff report and recommendations of the City Planning Commission on the proposed rezone at a public hearing, duly noticed and held in the manner required by law, now desires to approve such rezone, finding that the rezone: is consistent with General Plan policies that support development within SPAs and require a GPA/RZ to

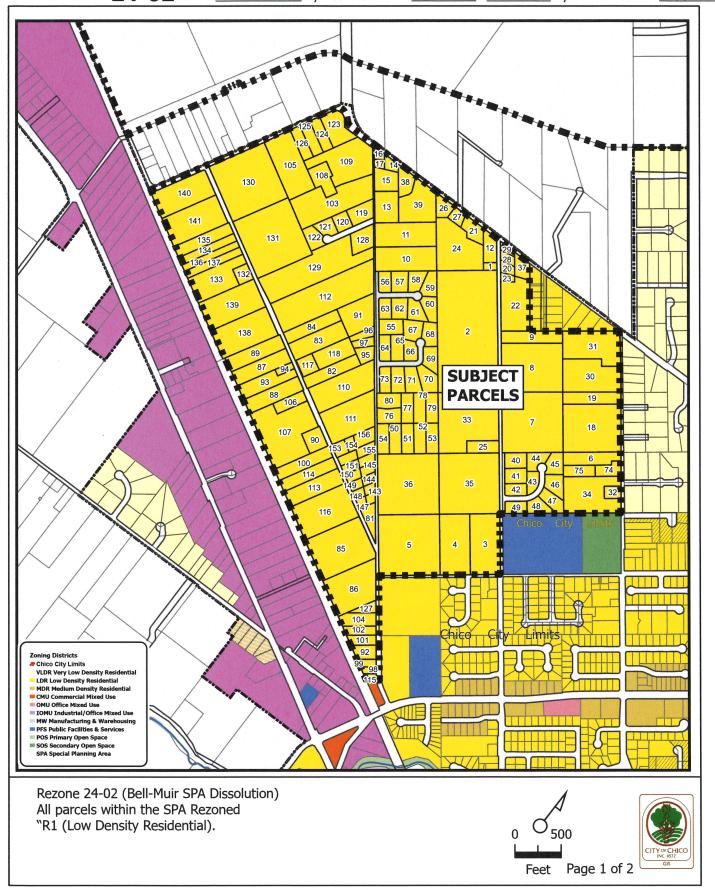
implement future planning efforts (LU-6.1, LU-6.1.1 and LU-6.1.2); the proposal is consistent with the City's continued support of sustainable land use patterns by both promoting infill development and managing the City's expansion into SPAs (LU-1, LU-1.3 and LU-2.3); by enabling individual subdivision projects to seek annexation on a case-by-case basis, including SUB 24-01, the GPA/RZ would allow denser development near the existing City's employment centers, reducing potential pressure to expand up to or past the westerly edge of Chico's Sphere of Influence, thereby helping to maintain the long-term boundaries between City growth and agricultural uses west of the Greenline (LU-1.2 and OS-5.1). Removing the SPA from the General Plan will also provide for development of higher density housing in the near term will help the City provide an adequate supply of residential land that also supports a wide range of housing types to meet future needs (ED-1.2, ED-1.2.3, and HE policies 4.1 and 4.2); no specific plan, neighborhood plan or area plan is applicable to the site; the Bell-Muir SPA, including the site for SUB 24-01, is physically suitable for the proposed Low Density Residential land use designation and associated development in that it is flat, adjacent to developed urban properties, and has adequate access to utilities and adjoining streets; and the design of SUB 24-01 is compatible with surrounding land uses and potential future residential subdivisions within the former Bell-Muir SPA; and

WHEREAS, on October 1, 2024, this Council adopted a Mitigated Negative Declaration and Mitigation Monitoring Program in connection with the GPA 24-02 and SUB 24-01 through City Council Resolution No. 71-24.

NOW, THEREFORE, be it ordained by the Council of the City of Chico as follows:

- **Section 1.** The pre-zoning of all that real property within the Bell-Muir SPA currently pre-zoned SPA shall be amended to R1 (Low Density Residential), as depicted on Exhibit I.
- **Section 2.** The recitals above are true and correct, and are hereby incorporated as findings in support of approving Rezone 24-02.
 - **Section 3.** The Community Development Director is hereby directed as follows:
 - a. To file a notice of determination for the rezone with the Butte County Clerk forthwith.
