3 **RESOLUTION OF THE COUNCIL OF THE CITY OF CHICO**
4 **ADDING SECTION 12R.04.057 TO THE CHICO MUNICIPAL CODE**
5 **REGARDING ALCOHOLIC BEVERAGES AT THE CHICO CREEK NATURE**
6 **CENTER**

7 NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Chico as
8 follows:

9 **SECTION 1.**

10 Section 12R.04.057 is hereby added to the Chico Municipal Code to read as follows:

11 **12R.04.057 Alcoholic Beverages – Chico Creek Nature Center.**

12 Notwithstanding Sections 12R.04.030, 12R.04.040, and 12R.04.050 above, any
13 person may sell and/or serve alcoholic beverages at the Chico Creek Nature Center pursuant
14 to a valid license issued by the California Department of Alcoholic Beverage Control, and
15 any person over the age of twenty-one (21) years may possess or consume alcoholic
16 beverages at the Chico Creek Nature Center.

17 Alcoholic beverage service and consumption shall be limited to events conducted
18 pursuant to a valid facility rental permit or other authorization approved by the City or its
19 designee and shall comply with all applicable federal, state, and local laws, regulations, and
20 permit conditions.

21 **SECTION 2.**

22 The rules set forth in this Resolution shall become effective upon approval by the
23 City Council and publication of a “Notice of Amendment to Park Rules” by the City Clerk
24 pursuant to Chico Municipal Code Section 12.16.010.
