

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHICO
AMENDING CHICO MUNICIPAL CODE (CMC) SECTION
18R.08.080 – UTILITY SERVICES**

Section 1. That Title 18R, entitled "DESIGN CRITERIA AND IMPROVEMENT STANDARDS", is amended as follows:

Section 2. That Section 18R.08.080, entitled "Utility services.", is amended as follows:

A. Location and Capacity.

- Existing overhead utility lines may be required to be relocated or placed underground when necessary to accommodate required public improvements or to address public safety concerns.

- Page 1 of 2

1 C. Certification. Prior to filing the final map, the subdivider shall provide the city with a
2 certification from each appropriate utility company. This certification shall state that the
3 company will provide its service to the subdivision and that the subdivider has met all
4 of the company's conditions necessary to provide the service.

5 D. Cost. Unless such is required by federal or state law and/or regulation, nothing in this
6 code shall be construed to require a subdivider to absorb the cost of such installation at
7 their sole cost.
