**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHICO
AMENDING SECTION 2R.04.180 ENTITLED, "CONFLICT OF INTEREST CODE" OF THE
CHICO MUNICIPAL CODE**

BE IT RESOLVED by the Council of the City of Chico that Section 2R.04.180 entitled, "Conflict of Interest Code" of the Chico Municipal Code, is amended to read as follows:

2R.04.180 Conflict of Interest Code.

- A. The Model Conflict of Interest Code as set forth in section 18730 of Title 2 of the California Code of Regulations, together with any amendments hereinafter enacted by the Fair Political Practices Commission, is hereby adopted by reference and constitutes the Conflict of Interest Code of the City of Chico.
- B. City officers and city employees subject to this Conflict of Interest Code shall file statements of economic interest with the City Clerk as provided for in the Model Conflict of Interest Code, no later than April 1st of the annual reporting period.
- C. Disclosure Categories. The disclosure categories for City officers and employees subject to this section shall be as follows:
 - 1. Disclosure Category 1: Officers and employees in this category must report all investments, business positions in, and income, including loans and gifts, from sources located in or doing business in the City of Chico and all interests in real property located within the City or within a two-mile radius of the City or any property owned or used by the City.
 - 2. Disclosure Category 2: Officers and employees in this category must report all investments, business positions in, and income, including loans and gifts, from sources which provide services, supplies, materials, machinery, or equipment of the type utilized by the designated officer or employee's department.
 - 3. Disclosure Category 3: Officers and employees in this category must report all interests in real property located within the City or within a two-mile radius of the city or any property owned by the City.
 - 4. Disclosure Category 4: Officers and employees in this category must report all investments, business positions in, and income, including loans and gifts, from sources

1 located in or doing business at the Chico Municipal Airport or in any Airport Zoning
2 District and all interests in real property located within any Airport Zoning District or
3 within a two-mile radius of any property within an Airport Zoning District.

4 5. Disclosure Category 5: Officers and employees in this category must report all
5 investments, business positions in, and income, including loans and gifts, from sources
6 located in or doing business in the City which engage in land development, construction
7 or the acquisition and sale of real property.

8 D. Appendix of Designated Positions. The designated city officers and employees and the
9 disclosure categories applicable to such designated city officers and employees shall be as

Such determinations shall be made in writing and shall include a description of the City consultant's duties.	

1 A copy of such determination shall be forwarded to the City Clerk and shall be retained by the City
2 Clerk for public inspection in the same manner and same location as the City's Conflict of Interest
3 Code.

4 F. Public Officials Who Manage Public Investments. It has been determined that positions listed
5 below manage investments and will file Statement of Economic Interest pursuant to Government Code
6 Section 87200.


