**Ordinance No. 1608**

**Council Bill No. 20-06**

*An Ordinance* amending Ordinance Number 1224 as previously amended, known as the Refuse Ordinance of the City of Corry, by increasing the charges for residential and commercial refuse service provided under the City of Corry refuse contract.

**BE IT ORDAINED** by the City Council of the City of Corry, Erie County, Pennsylvania, and it is hereby enacted by authority of the same.

**Section 1:** Section 6.A of Ordinance Number 1224 shall be amended to read as follows:

**Section 6.A: Charges for Service:** Each person producing garbage, rubbish, household rubbish and recyclable materials in the City, or being responsible for the disposal of, or the existence of such garbage, rubbish, household rubbish and recyclable materials, or for whom such garbage, rubbish, household rubbish and recyclable materials are removed by the City or its authorized agent, shall pay to the city a fee or charge as hereinafter provided for its services of collecting, hauling and disposing of such garbage, rubbish, household rubbish and recyclable materials.

**(a) Residential** - Each single-family dwelling unit or apartment unit (as defined in the Ordinance), shall pay a fee at the rate of \$24.35 per month for refuse service.

**(b) Commercial** - Each commercial unit (as defined in the Ordinance) which is provided refuse service by the City or its authorized agent, shall pay a fee at the rate of \$27.85 per month for refuse service.

**(c) Senior Citizen Rate** - Each residential dwelling unit in which all occupants residing therein have passed their 65th birthday (as defined in the Ordinance), shall pay the Residential rate of \$24.35 less a discount of \$3.00 per month for refuse service.”

**(d) Recycling Fee** – each refuse account is to be charged a fee of \$1.00 per account per month for recycling purposes.


**(e) Late Charges** – If the bill for refuse and recycling services are not paid by the fifteenth (15th) day of the month a penalty of 10% will be added per service, with a minimum penalty of \$.10 per service for any one bill. If the fifteenth (15th) day of the month falls on a Saturday, Sunday or holiday, bills may be paid without penalty on the next business day.

**Section 2:** The rates established herein shall take effect with the first full billing cycle commencing January 1, 2021.

**Section 3:** All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.
