A RESOLUTION OF THE CITY OF CORRY AUTHORIZING THE PREPARATION, EXECUTION AND SUBMISSION OF A 2020 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION IN THE AMOUNT OF APPROXIMATELY \$304,115 TO THE PENNSYLVANIA DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT, AND APPROVING THE CDBG RESIDENTIAL DISPLACEMENT AND RELOCATION ASSISTANCE PLAN, A MBE/WBE BUSINESS ENTERPRISE AND SOCIALLY/ECONOMICALLY RESTRICTED BUSINESS PLAN, THE FAIR HOUSING PLAN, THE EXCESSIVE FORCE POLICY AND A THREE YEAR COMMUNITY DEVELOPMENT PLAN.

WHEREAS, funds have become available under the 2020 Pennsylvania Community Development Block Grant Program through the Department of Community and Economic Development, Commonwealth of Pennsylvania; and,

WHEREAS, there was presented to the public at two (2) pre-advertised Public Hearings, held on May 26, 2020 and October 5, 2020, information concerning the 2020 Community Development Block Grant Program; and,

WHEREAS, there is hereby presented to the City Council of the City of Corry for their consideration and approval that the City of Corry consider submission of an Application for the 2020 Pennsylvania Community Development Block Grant Program to the Pennsylvania Department of Community and Economic Development for the following activities:

Purchase of used Fire Apparatus to Replace Engine 104; Code Enforcement and Administrative Costs.


WHEREAS, the City must adopt a CDBG Program Residential Displacement and Relocation Assistance Plan, a Three Year Community Development Plan, a MBE/WBE and Socially/Economically Restricted Business Plan, a Fair Housing Resolution, and an Excessive Force Policy, all in compliance with the Pennsylvania CDBG Program regulations.

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Corry that the Housing Authority of the County of Erie is hereby authorized to prepare the application for the 2020 Pennsylvania Community Development Block Grant Funds, in the amount of approximately \$304,115 and that the Mayor is hereby authorized to execute the Application and all documents required in the Application; and,


