A RESOLUTION OF THE CITY OF CORRY ALLOCATING UP TO \$225,000 OF STATE AND LOCAL FISCAL RECOVERY FUNDS (SLFRF) FOR USE IN COMPLETING THE SEWER GIS MAPPING IN PREPARATION OF THE NEW WASTEWATER TREATMENT PLANT.

WHEREAS, on March 11, 2021, the American Rescue Plan Act of 2021 was enacted and established the Coronavirus State Fiscal Recovery Fund and Coronavirus Local Fiscal Recovery Fund, which together make up the Coronavirus State and Local Fiscal Recovery Funds ("SLFRF");

WHEREAS, the City of Corry was awarded a total of Six Hundred Fifty-One Thousand, Eight Hundred Forty Dollars and Ninety-Two Cents (\$651,840.92);

WHEREAS, ARPA/SLFRF guidance identifies several eligible uses for the funds provided under ARPA/SLFRF, including investments in water, sewer or broadband infrastructure;

WHEREAS, the Treasury Department has issued guidance on eligible infrastructure projects "allowing for a broad range of necessary investments in projects that improve access to clean drinking water, improve wastewater and storm water infrastructure systems, and provide access to high-quality broadband service;"

WHEREAS, the Corry Municipal Authority ("CMA") is preparing for design and construction of a new wastewater treatment plant;

WHEREAS, the Board of the Corry Municipal Authority has requested that the City use up to \$225,000 of the funds provided to the City under ARPA/SLFRF to assist CMA in completing the sewer GIS mapping;

WHEREAS, City Council has determined that work to be performed by CMA relative to the sewer GIS mapping in preparation for the new wastewater treatment plant project qualifies as an infrastructure project eligible for funds under the SLFRF;

WHEREAS, City Council has determined it do be in the best interests of the City to allocate up to \$225,000 of the funds provided to the City under ARPA/SLFRF to facilitate CMA's completion of the sewer GIS mapping;

WHEREAS, City Council has determined to use ARPA/SLFRF funds in the amount of up to \$225,000 for completion of sewer GIS mapping as it constitutes a government investment in Water, Sewer or Broadband;

WHEREAS, City Council has determined that the use of ARPA/SLFRF funds for this sewer GIS mapping project is compliant with ARPA/SLFRF and is in the best interests of the City.

IT IS HEREBY RESOLVED by the City Council of the City of Corry, Erie County, Pennsylvania as follows:

- 1. The City of Corry hereby allocates up to \$225,000 of funds awarded to the City under ARPA/SLFRF to be used for CMA's sewer GIS mapping.
- 2. The allocated funds shall be held by the City. The City shall make payments directly to CMA's engineer, Burgess & Niple, for services performed by Burgess & Niple as part of the sewer GIS mapping project.
- 3. The City Administrator and the Mayor are authorized to execute any and all documents necessary to accomplish the allocation of ARPA/SLFRF to CMA's sewer GIS mapping project.
