ORDINANCE 282

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF ELKINS, WEST VIRGINIA TO REPEAL ELKINS CITY CODE §150.065 THROUGH §150.070 REGARDING ENFORCEMENT AGENCY

WHEREAS, the Common Council previously established an Enforcement Agency by adopting an Ordinance on October 17, 1963, and

WHEREAS, the Enforcement Agency had the authority to "investigate dwellings and building conditions and conduct hearings;" and

WHEREAS, the Enforcement Agency continued to carry out its directives concerning dwellings and buildings over a period of years; and

WHEREAS, the Common Council established a Code Enforcement Department as defined by Title 87, West Virginia Code of State Rules, Section 7-2 in December 2011 with the full-time employment of a Code Enforcement Official; and

WHEREAS, the establishment of the Code Enforcement Department allowed the Common Council to pass ordinances adopting the West Virginia State Building Code, which among other Codes includes the International Property Maintenance Code, the Vacant Structure ordinance, the Rental Inspection ordinance, the Enforcement of External Sanitation and the Common Nuisance Violations ordinance and the Unsafe Structures ordinance; and

WHEREAS, the Code Enforcement Department Official is licensed and certified by the West Virginia State Fire Commission as set forth in Title 87 West Virginia Code of State Rules, Series 7; and

WHEREAS, once the Code Enforcement Department was established followed by the subsequent adoption of the various State building, safety and sanitation standards through the ordinance

process, the Enforcement Agency was no longer needed, and its purpose had been superseded by the

establishment of the Code Enforcement Department; and

Whereas, the information concerning the Enforcement Agency and the Code Enforcement

Department has been presented to both the Public Safety Committee and the Rules and Ordinance

Committee and both Committees have recommended that the City Code be amended to reflect the

current status of City procedures concerning Code Enforcement by repealing the relevant sections of the

City Code regarding the Enforcement Agency; and

WHEREAS, it is in the best interest of the citizens of the City of Elkins to clarify and define the

responsibility of the enforcement of all of the City Code provisions regarding the condition and safety

of structures:

NOW THEREFORE BE IT ENACTED AND ORDAINED BY THE COMMON

COUNCIL OF THE CITY OF ELKINS, that City Code §150.065 through §150.070 BE

REPEALED.

If any portion of this Ordinance shall, for any reason, be declared invalid by any court of competent

jurisdiction, such invalidity shall not affect the remaining provisions hereof and Common Council

determines that it would have adopted this Ordinance without the invalid provision.

This Ordinance shall be effective upon passage.
