ORDINANCE NO. 01 -21

AN ORDINANCE TO APPOINT AN ACTING FISCAL OFFICER AND DECLARING AN EMERGENCY

WHEREAS, the Village's Fiscal Officer is incapacitated, and therefore incapable of performing duties imposed by virtue of her office; and

WHEREAS, it is vital to the Village of Elmore that an official be appointed to carry out the fiscal officer's duties to pay bills, process payroll, report financial matters to the Mayor and Council, and such other matters attendant to the responsibilities of the fiscal officer; and

WHEREAS, the Mayor has appointed Gretchen Densic to be the Acting Fiscal Officer until such time as it is no longer necessary to have a substitute for the Fiscal Officer, and

WHEREAS, the Mayor proposes said appointment be on the terms as set out herein; and

WHEREAS, said appointment is not effective until approved by Council;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELMORE, OHIO THAT:

<u>Section 1.</u> The Mayor's appointment of Gretchen Densic as Acting Fiscal Officer for The Village of Elmore is approved.

<u>Section 2.</u> During her term as Acting Fiscal Officer, Gretchen Densic shall be paid \$17.96 per hour and shall be entitled to the other benefits of full-time employment with the Village.

<u>Section 3.</u> As Acting Fiscal Officer Gretchen Densic is excused from the requirement that the Fiscal Officer must reside in the Village, and her residence outside the Village of Elmore is approved.

Section 4. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health and safety to immediately provide for the payment of bills, the collection of revenue, and the continuation of Village services vital to the residents of the Village.

<u>Section 5.</u> That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
