**ORDINANCE NO. 2-2026**

**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR OF THE VILLAGE OF ELMORE, OHIO, TO ENTER INTO CONTRACTS FOR 1) MAINTENANCE OF COMPONENTS AND 2) INSULATOR CLEANING SERVICES AT THE MERLE HARDER SUBSTATION,**

**RECITALS:**

WHEREAS, the Village of Elmore, Ottawa County, Ohio (the "Village") owns and operates the Merle Harder Substation, which serves as a critical component of the Village's electrical infrastructure; and

WHEREAS, it is necessary and in the public interest to maintain the components of the Merle Harder Substation as described in Exhibit A attached hereto and incorporated herein by reference; and

WHEREAS, it is further necessary to provide for the cleaning of the insulators at the Merle Harder Substation as described in Exhibit B attached hereto and incorporated herein by reference; and

WHEREAS, the Village Council finds that the authorization of such work is necessary for the continued safe and efficient operation of the Village's electrical facilities; and

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Elmore, Ottawa County, Ohio, that:

**SECTION 1. Authorization of Maintenance Work.**

The Village Administrator of the Village of Elmore is hereby authorized and directed to enter into a contract with an appropriate contractor for the maintenance of the components of the Merle Harder Substation, as more particularly described in Exhibit A attached hereto. The total cost of such work shall not exceed \$22,900.00. The Administrator is further authorized to execute all documents necessary to effectuate this authorization.

**SECTION 2. Authorization of Insulator Cleaning.**

The Village Administrator of the Village of Elmore is hereby authorized and directed to enter into a contract for the cleaning of the insulators at the Merle Harder Substation, as more particularly described in Exhibit B attached hereto. The total cost of such work shall not exceed \$21,300.00.

The Administrator is further authorized to execute all documents necessary to effectuate this authorization.

**SECTION 3. Effective Date.**

This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
