ORDINANCE NO. 02 -21

**AN ORDINANCE TO AMEND SECTION 1105.02
OF THE CODIFIED ORDINANCES
OF THE VILLAGE OF ELMORE
BY ADDING A DEFINITION RELATING TO
BEER, LIQUOR, AND WINE PRODUCTION
AND DECLARING AN EMERGENCY.**

WHEREAS, the Village Zoning Ordinance does not allow for the craft or artisanal production of beer, liquor, or wine in the central business district nor in the general business district; and

Whereas, the limited production and retail sale of these beverages could enhance the business districts by fostering economic development that would benefit the Village and other merchants in said districts;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELMORE, OHIO THAT:

Section 1. Section 1105.02 of the Codified Ordinances of the Village of Elmore is amended by adding the following definition:

“Craft or artisanal production of beer, liquor, or wine means brewing of beer on premises of up to fifty thousand (50,000) gallons per calendar year or the distilling of liquor on premises of up to fifty thousand (50,000) gallons per calendar year, or making wine on premises of up to fifty thousand (50,000) gallons per calendar year. It shall also include the sale of said products for on-premises or off-premises consumption.”

Section 2. This Ordinance is hereby declared to be an emergency measure necessary or the immediate preservation of the public health and safety to immediately provide for necessary zoning changes which must be enacted pursuant to Codified Ordinance No. 1107.25 within thirty (30) days.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
