

VILLAGE OF ELMORE

ORDINANCE NO. 03-2026

AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH MEDICAL MUTUAL COSE MEWA HSA 3,500 and PPO HSA 2,500 FOR HEALTH INSURANCE, HRI FOR VISION AND DENTAL INSURANCE, AND MUTUAL OF OMAHA FOR LIFE INSURANCE FOR VILLAGE EMPLOYEES. THIS INCLUDES AN EMPLOYEE PAYROLL DEDUCTION FOR HEALTH INSURANCE AND TO SET VILLAGE HSA CONTRIBUTIONS AND TO DECLARE AN EMERGENCY.

WHEREAS, it is necessary to enter into an agreement for the provision of employee benefits;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF ELMORE, OTTAWA COUNTY, OHIO:

SECTION 1. The Village Administrator is hereby authorized and directed to enter into an agreement with Medical Mutual COSE MEWA HSA 3,500 & PPO HSA 2500 for health insurance, HRI for vision and dental insurance, and Mutual of Omaha for life insurance for village employees. This includes an employee biweekly payroll deduction of \$38.14 to \$337.26 for health insurance, depending on the plan chosen by each employee for health insurance.

SECTION 2. The Village shall contribute to employee HSA accounts at the rate of \$1,000.00 per year for a single plan participant and \$2,000.00 per year for a family plan participant.

SECTION 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health and safety to immediately provide for the payment of employee benefits without interruption and to provide assurance that the Village will honor its employee benefit program for medical benefits.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were at meetings open to the public in compliance with all legal requirements of the Village of Elmore and the State of Ohio.


