

VILLAGE OF ELMORE

ORDINANCE NO. 7-20

AN ORDINANCE AGREEING AS A CONDITION OF ANNEXATION

TO ASSUME MAINTAINANCE OF A SECTION OF ROAD

AND DECLARING AN EMERGENCY

WHEREAS, the County Engineer has identified a portion of the Portage River South road that will be divided or segmented by the boundary line between the Township and the Village of Elmore in the proposed annexation and

WHEREAS, the Village is willing to assume the maintenance of said road; and

WHEREAS, section 709.023 (E) (7) of the Ohio Revised Code allows for the assumption of said maintenance by the Village,

Now, THEREFORE, be it **ORDAINED** by the Council of the Village of Elmore, Ohio that:

Section 1. The Village hereby agrees to assume the maintenance of that part of the Portage River South Road right-of-way described as the south half of said right-of-way across Parcel 11 currently owned by Gregory A. and Jessica L. Blausey, and across Parcel 12 currently owned by Robert H. and Claudine L. Kuhlman, and across Parcel 13 to the E Line NE ¼ Section 24 currently owned by the Joseph J. and Marie P. Schedel Foundation.

Section 2. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health and safety to immediately provide notice to the County Board of Commissioners of the Village's agreement to maintain the road involved in the annexation under its consideration.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
