ORDINANCE NO. 07-2024

**AN ORDINANCE TO AUTHORIZING THE
VILLAGE ADMINISTRATOR
TO AWARD A CONTRACT RELATING TO
SOLID AND BULK WASTE REMOVAL**

WHEREAS, the Village of Elmore Council has determined that it is necessary to have a comprehensive solid waste collection system so there is a weekly removal from the curb and/or alley and for final disposal of all solid and bulk waste within the Village of Elmore corporation limits; and,

WHEREAS, the Village solicited proposals for solid waste collection by appropriate publication; and,

WHEREAS, a proposal was received with various options; and,

WHEREAS, the Village of Elmore Council desires to authorize the Village Administrator to award a contract for Solid Waste Collection and Disposal Services; and,

NOW THEREFORE, in consideration of the foregoing, it is hereby **ORDAINED** by the Council of the Village of Elmore that:

Section 1. That the Solid Waste Collection and Disposal Services are necessary to protect the property of the residents and to provide monthly bulk disposal and weekly removal from the curb and/or alley and for final disposal of all solid waste is hereby approved.

Section 2. That this Council authorizes the Village administrator to award a contract and execute all documents necessary for Stephens Disposal to complete said Solid Waste Collection and Disposal Services .

Section 3 That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
