

**VILLAGE OF ELMORE**

**ORDINANCE NO. 09-21**

**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR  
TO APPLY FOR A NATURAL RESOURCES GRANT FOR A PUBLIC  
BOATING ACCESS AND DECLARING IT AN EMERGENCY**

WHEREAS the State of Ohio through the Department of Natural Resources Waterways Safety Fund administers financial assistance for public boating access, and

WHEREAS the Village of Elmore desires financial reimbursement under the Paddling Enhancement Grant Program,

NOW THEREFORE be it ORDAINED by the Village of Elmore as follows:

Section 1. The Village of Elmore approves of filing an application for Paddling Enhancement Grant financial assistance.

Section 2. The Village Administrator is hereby authorized and directed to file and execute an application with the Ohio Department of Natural Resources and provide all information and documentation required to be eligible for possible financial assistance.

Section 3. The Village of Elmore agrees that it has and will obligate the funds required to satisfactorily complete the project under the terms and conditions of the Cooperative Agreement if the project is accepted for financial assistance.

Section 4. This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health and safety to immediately provide for the submission of a grant application prior to its deadline.

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 122.22 of the Ohio Revised Code.
