ORDINANCE NO. 10-2023

**AN ORDINANCE TO AMEND ORDINANCE NO. 3-2023
TO CORRECT THE NUMBER OF ACRES ANNEXED
TO 2.771 ACRES
AND DECLARING AN EMERGENCY.**

WHEREAS, Ordinance No.3-2023 provided for the annexation of 2.97 acres of territory to the Village of Elmore; and,

WHEREAS, the true number of acres annexed is 2.771 acres which reflects the territory to be annexed excluding the property in the right-of-way of the adjoining road; and,

WHEREAS, the property in the right-of-way, if annexed, would create a gap in road maintenance; and,

WHEREAS, the Board of Commissioners of Ottawa County has changed its approval of the annexation to 2.771 acres;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELMORE, OHIO THAT:

Section 1. Ordinance No. 3-2023 is hereby amended to show that 2.771 acres of territory is annexed to the Village of Elmore.

Section 2. This Ordinance is necessary for the immediate preservation of the public peace, health, and safety in that the annexation must be concluded to offer municipal services to the territory, including Village police protection.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and of any of its committees that resulted in such formal action, were in meetings open to the

public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
