

**VILLAGE OF ELMORE
ORDINANCE NO. 11-2024**

**AN ORDINANCE AMENDING ORDINANCE 11-2023 CREATING A DESIGNATED
OUTDOOR REFRESHMENT AREA FOR THE VILLAGE OF ELMORE AND ENACTING
REGULATIONS.**

WHEREAS, THE Village of Elmore Council approved Ordinance 11-2023, Creating A Designated Outdoor Refreshment Area (“DORA”) on March 13, 2023,

WHEREAS, the Council has also duly considered the language of the Ordinance should be revised for explanation purposes,

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELMORE, OTTAWA COUNTY, OHIO THAT:

Section 1. Council determines that all public hearings of Section 4301.82 of the Ohio Revised Code prior to the passage of this Ordinance have been met.

Section 2. Only official DORA cups may be used for DORA beverages. The amended agreement will require said DORA cups shall be purchased from the Village of Elmore, and the selling of the empty cups shall be divided as set out in Exhibit A, attached hereto.

Section 3. The Clerk of Council is hereby instructed to forward a copy of this Ordinance to the Ohio Division of Liquor Control and to the investigative unit of the Ohio Department of Public Safety, in accordance with the Ohio Revised Code Sections 4301.82(c) and 4301.82 (F)(3).

Section 4. The rules, regulations, terms, and conditions contained in Exhibit A, attached hereto, are incorporated herein by reference, and made part hereof and shall be as effective as if they were written in the main body of this Ordinance.

Section 5. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and any of its committees that resulted in such formal actions, were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


Section 6. This Ordinance shall be in full force and effect from the earliest time allowed by law.


