WHEREA	S, it was duly r	noved and seconded for	the adoption of the following Ord	linance:

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELMORE, OHIO THAT:

<u>Section 1.</u> It is necessary to levy a tax outside the ten-mill limitation to provide for the collection and disposal of garbage or refuge, including yard waste, i.e., solid waste collection, as set out in Section 5705.19(V) of the Ohio Revised Code (O.R.C.).

<u>Section 2.</u> Pursuant to Section 5705.03 O.R.C., the Council of the Village of Elmore hereby requests that the Ottawa County Auditor certify to the Village the dollar amount of revenue that would be generated by a renewal of a three (3) mill tax levy for said purpose.

<u>Section 3.</u> The term of years of the proposed renewal is five years to first be levied in tax year 2022 and first collected in calendar year 2023.

<u>Section 4.</u> The tax is to be levied upon the entire territory of the Village of Elmore, and the ballot measure proposed herein shall be submitted to the entire territory of the Village of Elmore. The Village of Elmore, Ohio has territory in two counties: Ottawa County and Sandusky County.

<u>Section 5.</u> The question of this tax is proposed to appear on the ballot at the election to be held on November 2, 2021.

<u>Section 6.</u> It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of the Village of Elmore and the State of Ohio.
