ORDINANCE NO. 18-23

AN ORDINANCE AMENDING ORDINANCE 17-23 RATE SCHEDULES

FOR SOME VILLAGE EMPLOYEES

AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance 17-23 changed the pay scale for some employees in Section 3; and,

WHEREAS, some employees did not receive the fully intended 8% compensation increase as intended due to Section 3 limiting some employees to less than that amount,

NOW THEREFORE, BE IT ORDAINED by the Council of the VILLAGE OF ELMORE, OHIO THAT:

Section 1. Section 3 of Ordinance number 17-23 is hereby repealed.


Section 2. The rate of compensation for the positions of custodian, serviceman I, serviceman II, serviceman III, working foreman, and contingent serviceman III are all advanced 8% of their job classification current rate schedule. This is being completed as a market rate adjustment for their respective classifications. This change will be effective retroactive to the passage of Ordinance 17-23.



Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the citizens of the Village of Elmore to provide for ongoing and uninterrupted utility service and shall take effect immediately after its passage and approval by the Mayor.




