

**VILLAGE OF ELMORE**

**ORDINANCE NO. 20-2023**

**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR  
TO ENTER INTO CONTRACTS IN ACCORDANCE  
WITH THE PROVISIONS OF SECTIONS 731.141 and 9.17  
OF THE OHIO REVISED CODE**

**WHEREAS**, the Village Administrator has authority under section 731.141 to enter into contracts and approve expenditures, subject to certain limits; and,

**WHEREAS**, the Village Administrator was limited to contracts of fifty thousand dollars (\$50,000) or less; and,

**WHEREAS**, sections 731.14 and 9.17 of the Ohio Revised Code will increase the authority of the Village Administrator to contract up to the amount specified in section 9.17 O.R.C. and;

**WHEREAS**, section 9.17 O.R.C. increases the Village Administrator's authority to contracts of seventy-five thousand dollars (\$75,000) in calendar year 2024 and increases said amount by three percent (3%) a year thereafter as determined and published by the director of commerce,

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELMORE, OHIO THAT:**

**Section 1.** The authority of the VILLAGE ADMINISTRATOR to enter into contracts without bidding is increased to seventy-five thousand dollars (\$75,000) starting October 3, 2023, or as soon as this Ordinance becomes effective, whichever is later.

**Section 2.** Said seventy-five thousand dollars (\$75,000) shall increase in calendar year 2025 and every year thereafter as set out in section 9.17 of the Ohio Revised Code.

**Section 3.** The Village Administrator shall have the authority to enter into contracts, to approve expenditures, purchase supplies and materials, and provide for any work under the Village

Administrator's supervision as set out in sections 731.141 and 9.17 of the Ohio Revised Code as enacted in House Bill 33, effective October 23, 2023.

**Section 4.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
