

VILLAGE OF ELMORE

ORDINANCE NO. 22 -21

**AN ORDINANCE TO AUTHORIZE THE EXECUTION AND
ACCEPTANCE OF A GRANT FROM ODNR,
A PADDLING ENHANCEMENT GRANT
AND DECLARING AN EMERGENCY**

WHEREAS, the Village applied for and received a grant award from the Ohio Department of Natural Resources (ODNR) funded by federal funds under the terms and conditions of a Recreational Boating Safety Program; and

WHEREAS, said grant is the subject of a Subrecipient Grant Agreement between ODNR and the Village of Elmore and is known as a Paddling Enhancement Grant in an amount not to exceed \$75,000; and

WHEREAS, the Village approved of said agreement and desires to make improvements as described in said grant;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELMORE, OHIO THAT:

Section 1. Council hereby approves said grant agreement and authorizes the Village Administrator to execute said agreement on behalf of the Village of Elmore, Ohio.

Section 2. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health and safety to immediately provide for the execution of a Subrecipient Grant Agreement in a timely manner to secure funding for a capital improvement.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
