

**VILLAGE OF ELMORE**

**ORDINANCE NO. 23-21**

**AN ORDINANCE TO ENTER INTO A CONTRACT WITH THE  
POGGEMEYER DESIGN GROUP FOR PROFESSIONAL SERVICES  
FOR THE W. PORTAGE RIVER SOUTH ROAD SANITARY SEWER  
AND DECLARING IT AN EMERGENCY.**

**WHEREAS**, the Village of Elmore has proposed an extension of its sanitary sewer to serve an area on West Portage River South Road; and

**WHEREAS**, the Village needs engineering, design, and other professional services to facilitate the completion of the improvements; and

**WHEREAS**, the Poggemeyer Design Group through direct negotiation or requests for proposals or qualifications has submitted the attached contract to do the required engineering and design work for the improvement; and

**WHEREAS**, Council approves said contract;

**NOW, THEREFORE**, be it **ORDAINED** by the **COUNCIL** of the **VILLAGE OF ELMORE**, **OTTAWA COUNTY, OHIO**:

**SECTION 1.** The agreement attached hereto between the Village of Elmore and the Poggemeyer Design Group is hereby approved.

**SECTION 2.** The Mayor and Fiscal Officer are authorized to execute the agreement on behalf of the Village.

**SECTION 3.** The Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health and safety to immediately provide for the execution of the Agreement in a timely manner to ensure that the project is commenced in time to secure available funding so the opportunity to provide sanitary sewer service is not lost.

**SECTION 4.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of

this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


