VILLAGE OF ELMORE

ORDINANCE NO. 29-21

AN ORDINANCE TO AMEND SECTION 351.18(b) OF THE CODIFIED ORDINANCES OF THE VILLAGE OF ELMORE AND TO ADD SECTION 301.362 TO IMPROVE PARKING IN THE VILLAGE

WHEREAS, parking in the Village of Elmore could be improved with amendments to the parking ordinance; and,

WHEREAS, said improvements encompass changing restricted times and by adding special parking for charging electric vehicles and for designated service and business vehicles;

NOW THEREFORE, in consideration of the forgoing it is hereby ORDAINED by the Council of the Village of Elmore, Ohio that:

Section 1. Ordinance 351.18(b)(2) and 351.18(b)(3) are hereby amended by eliminating the 7:00 AM and 6:00 PM time limits and changing them to 9:00 AM and 5:00 PM. Said ordinances shall now be as follows:

- (2) Two hours parking between 9:00 AM and 5:00 PM on Rice Street between Toledo and Maple Streets, except for Sundays and holidays.
- (3) Two hours parking between 9:00 Am and 5:00 PM on Toledo Street between Rice and Clinton Streets (Toledo Street business district).

<u>Section 2.</u> Ordinance 351.18(b)(6) and (b)(8) are repealed in their entirety and replaced with the following:

- (6) The North and South Parking Lots along the North Coast Inland Trail have 24-hour parking limits except as noted below.
 - i. Handicap Parking is reserved for three parking spaces.
 - ii. Two parking spaces are limited to ten-minute parking.

- iii. Seven parking spaces are limited to two-hour parking.
- Two parking spaces are reserved for electric vehicles in the process of charging batteries.
- v. Nine parking spaces are reserved or restricted to service and business vehicles as defined in section 301.362 of the Codified Ordinances of the Village of Elmore, Ohio. Service vehicles are limited to 90 days of parking. Business vehicles are limited to 24-hour parking.
- (8). The lot at 408 Rice Street has a twenty-four-hour parking limit and one parking space located therein shall be designated as handicap parking.

<u>Section 3.</u> A new provision is hereby added to section 351.18 of the Codified Ordinances of the Village of Elmore. It is as follows:

351.18(b)(11) The parking restrictions noted above relating to handicap parking, electric vehicle parking, service and business parking, 10-minute parking, two-hour parking, and 24-hour parking shall be designated by signs in such locations as the Chief of Police shall determine. Council, by a majority vote may change the locations if it deems said action advisable.

<u>Section 4.</u> The Codified Ordinances of the Village of Elmore are hereby amended by adding a new section 301, 326 as follows:

301.362 Service or Business vehicle means a vehicle meeting one of the following requirements:

- a). A vehicle parked while waiting for repair by a garage or service station located in the central business district.
- b). A vehicle used by a person employed in the central business district and used to drive to and from work.

Service or Business vehicles must be designated by the Village Administrator or Police Chief. A designation under a) above shall expire on the 90th day. If a requested designation is denied, the applicant may appeal in writing within ten business days to the Elmore Village Council for a hearing to determine if the original decision should be overruled by a majority vote.

<u>Section 5.</u> That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council

and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
