ORDINANCE NO. 29-22

AN ORDINANCE AMENDING THE ORDINANCE 34-21 FOR WAGE SCHEDULES FOR CERTAIN EMPLOYEES OF THE VILLAGE OF ELMORE, OTTAWA COUNTY, OHIO, FOR THE FISCAL YEAR OF 2023.

WHEREAS Ordinance No. 34-21 passed December 13, 2021 which amended prior Ordinances respecting job classifications, pay ranges and compensation needs to be amended.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Elmore, Ottawa County, Ohio that the pay scale for employees and departments shall be as follows:

SECTION 1. That Ordinance No. 10-20 passed December 13, 2013, be amended to read as follows, and shall be effective as of January 1, 2023.
