**A RESOLUTION TO ADOPT THE
SOLID WASTE MANAGEMENT PLAN FOR
THE OTTAWA-SANDUSKY-SENECA
JOINT SOLID WASTE MANAGEMENT DISTRICT .**

WHEREAS, The Village of Elmore, Ohio met in regular session on the 22 day of May 2023; and

WHEREAS, It was duly moved and seconded for the adoption of the following Resolution; and

WHEREAS, The Village of Elmore is located within the jurisdiction of the Ottawa-Sandusky-Seneca Joint Solid Waste Management District (District); and

WHEREAS, The District Policy Committee prepared and adopted a final draft of the Solid Waste Management Plan in accordance with the Ohio Revised Code Sections 3734.53, 3734.54, and 3743.55; and

WHEREAS, The District has provided a copy of the Draft Final Solid Waste Management Plan for ratification to each legislative authorities of the District; and

WHEREAS, The Village of Elmore must decide whether it approves of said Solid Waste Management Plan within ninety days of receipt of the Final Draft Plan

NOW THEREFORE, BE IT RESOLVED, BY THE VILLAGE OF ELMORE COUNCIL, OTTAWA COUNTY OF OHIO;

Section 1. The Village of Elmore either:

- A. Approves the Districts Solid Waste Management Plan: or
- B. Disapproves the Districts Solid Waste Management Plan:

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


