Whereas, the Village of Elmore seeks to perform preventative maintenance tasks on the electrical substations owned by the Village of Elmore; and

Whereas, the Village of Elmore intends to allow Electrical Power Systems Testing & Engineering Services, to perform the necessary work with labor and parts,

Whereas, this legislation will provide the execution of an agreement as well as designating a dedicated repayment source; now therefore,

BE IT RESOLVED by the Council of the Village of Elmore, Ohio:

SECTION 1. That David Hower, Village Administrator is hereby authorized to sign all documents for and enter into an agreement with Electrical Power Systems Testing & Engineering Services for their professional services to perform preventative maintenance tasks on Electrical Sub 1 (Rt. 51) and Electrical Sub 2 (Merle Harder Substation) on behalf of the Village of Elmore Ohio in the amount not to exceed \$38,000.00.

SECTION 2. That the dedicated source of repayment will be the Electrical Operating Fund (5301).

SECTION 3. That this resolution shall take effect and be in force from and after the earliest period allowed by law.
