A RESOLUTION PURSUANT TO SECTION 1107.14 (b) OF THE CODIFIED VILLAGE ORDINANCES TO INITIATE CONSIDERATION OF AMENDMENTS TO THE ZONING ORDINANCE

WHEREAS, The Village Council is authorized initiate consideration of zoning amendments under Section 1107.14 (b) of the Village's ordinances; and

WHEREAS, new uses for property have been proposed which were not anticipated when zoning was last amended; and

WHEREAS, said uses, if properly integrated, may enhance the quality of life and economic development in the Village;

Now, THEREFORE, be it RESOLVED by the Council of the Village of Elmore, Ohio that:

- 1. The Planning Commission consider the following zoning text amendments:
 - a. That Section 1105.02 (DEFINITIONS) be amended by adding the following new definition:

"Craft or artisanal production of beer, liquor, or wine means the brewing of beer on premises of up to fifty thousand (50,000) gallons per calendar year or the distilling of liquor on premises of up fifty thousand (50,000) gallons per calendar year or making wine on premises of up to fifty thousand (50,000) gallons per

calendar year. It shall also include the sale of said products for on-premises or off-premises consumption."

b. That Sections 1157.02 and 1161.02 be amended by adding a new permitted use in the Central Business District and General Business. Said new use is:

"Craft or artisanal production of beer, liquor, or wine."

c. That Section 1161.14 (Conditional Permitted Uses) in the Central Business District be amended as follows:

1161.14 CONDITIONAL PERMITTED USES.

- (a) Multiple Family Dwellings.
- (b) Single family or two-family dwellings except that they shall be located only on the second or higher floor of any building located on Rice Street in the Central Business District.
- (c) Motel, hotel, or apartment hotel except that they shall be located only on the second or higher floor of any building located on Rice Street in the Central Business District.
