

SECTION 5705.03 O.R.C.

RESOLUTION TO THE COUNTY AUDITOR REQUESTING CERTIFICATION OF THE TOTAL CURRENT TAX VALUATION AND THE NUMBER OF MILLS REQUIRED TO GENERATE A SPECIFIC AMOUNT OF REVENUE OR THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY A SPECIFIED NUMBER OF MILLS.

WHEREAS It is necessary to levy a tax outside the ten-mill limitation for a purpose authorized by the Revised Code as set out below.

NOW THEREFORE, pursuant to section 5705.03 of the Revised Code the Village of Elmore (hereafter the "subdivision") hereby resolves that it is necessary to levy a tax outside the ten-mill limitation as authorized by:

section 5705.19 (g) (subsection)

OR

section _____ (specify statute)

Specifically, for the purpose of:

MAINTENANCE AND REPAIR OF STREETS AND ALLEYS

And it is further

RESOLVED THAT:

1. The tax under consideration would be the number of mills required to generate \$ _____ annually.

OR

The tax under consideration would be the dollar amount of revenue that would be generated annually by 3.0 mills.

2. Said tax would be a renewal levy; the rate is the same rate as the existing tax levy.

3. The tax is for a term of 5 years

OR

The tax is for a continuing period.

4. The subdivision has territory in the County or Counties of Ottawa and Sandusky, Ohio.

X The tax is to be levied upon the entire territory of this subdivision and the ballot measure shall be submitted to the entire territory of the subdivision.

OR

_____ The tax is to be levied on a portion of the territory of the subdivision namely:

_____ and said territory is the portion of the subdivision to which the ballot measure shall be submitted.

5. The election at which the question of the tax shall appear on the ballot will be held On the 5TH day of November, 2019

6. The tax year in which the tax will first be levied is 2020. The calendar year in which the tax will first be collected is 2021.

7. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of the Village of Elmore and the State of Ohio.

8. This Resolution is hereby declared to be an emergency measure in the interest of public peace, health and safety of the citizens of Elmore, and shall be in full force and effect immediately after its passage.

The Fiscal Officer is hereby instructed to certify this Resolution to the County Auditor without delay.


