A Resolution Describing the Responsibilities of The Village of Elmore and W. Portage River South
Property Owners for The W. Portage River South Sewer Extension

WHEREAS, The Village of Elmore will be installing a sanitary sewer line to serve the residents of W. Portage River South Rd. in Elmore Ohio, and

WHEREAS, said sanitary sewer line will be a low-pressure system, and

WHEREAS, the Village will own and maintain the force mains, lateral connections to the mains and the grinder pumps, and

WHEREAS, the Village will cover the cost of these components to the project as well as electrical connections to the pump stations, and installation of all control panels for the residences, and

WHEREAS, the Village of Elmore will be responsible for maintaining the system and all its components, and

WHEREAS, the property owners will be responsible for abandonment of their current system, and

WHEREAS, the property owners will be responsible for connection to the new system from the existing residence sanitary sewer to the grinder pump and shall be responsible for the maintenance and repair of this part of the system (except for the grinder pumps), and WHEREAS, the property owners will be responsible for all costs of electricity to operate the grinder pumps, and

WHEREAS, property owners will need to allow the Village to have permanent access to their property, typically by a recorded easement;

NOW THEREFORE, be it RESOLVED by the Council of the Village of Elmore Ohio by a two thirds (2/3) vote of the members concurring in the following:

- **Section 1.** The Village of Elmore shall proceed with the installation of the sewer in accordance with the drawings and documents from Poggemeyer Design Groups.
- **Section 2.** This installation shall occur only after securing the financing in accordance with WPCLF funding requirements.
- **Section 3.** The aforementioned conditions shall apply to all individuals entering into contract with the Village for their residence.
