WHEREAS, the Fairfield Town Council has reviewed the proposed amendments to the Fairfield Town Code:

NOW THEREFORE, be it ordained by the Town Council of Fairfield Town, in the State of Utah, that certain sections of Title 3.1.00 of the Town Code be amended as follows:

The ordinance to amend ~~the~~ Section 3.1.110 by deleting "Licensing Official" and replacing with "Town Recorder", and adding ~~the~~ Section 3.1.30(H) , declaring the ~~Mayor or designee~~ as the Town Licensing Official shall be the Town Recorder and also adding Section 3.1.30(I) declaring the Code Enforcement Officer shall be the Mayor, Fire Chief, or Code Enforcement Officer appointed by the Mayor with the consent of the Town Council, and amend Section 3.1.130(A) deleting "Licensing Official" and replacing with "Code enforcement Officer". ~~to Section 3.1.00.~~

Section 3.1.110. Records Maintained.

The Town Recorder shall maintain license registers as a permanent file. All beer licenses and general business licenses will be kept and maintained for four (4) years after being issued. Copies of annual license certificates will be maintained and retained for one (1) year after issued. The index shall state the license number, names to whom issued, time of issuance and the period covered, the place of business, the kind of business to be transacted, the amount paid and such other information as may be considered necessary.

Section 3.1.30. Licenses Application Process and Renewal.

- H. The licensing official shall be the Town Recorder.
- I. The Code Enforcement Officer shall be the Mayor, Fire Chief or Code Enforcement Officer appointed by the Mayor with the consent of the Town Council.

Section 3.1.130. Suspension or Revocation of License.

- A. The Code Enforcement Officer may suspend or revoke a license if any of the following conditions apply:

Effective Date: This Ordinance shall become effective immediately upon passage and adoption.
