ORDINANCE NUMBER 2025 02

AN ORDINANCE AMENDING TITLE XI OF THE CODE OF
THE VILLAGE OF FLANAGAN

WHEREAS, the Village of Flanagan Code of Ordinances (Code), Title XI, Chapter 111 regulates Amusement and Leisure Businesses;

WHEREAS the Code, Title XI, Chapter 111, Section 111.02 regulates licensing of the foregoing;

WHEREAS, the Village Board of Trustees finds that Amendment of Section 111.02 would be suitable and beneficial for the public;

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE BOARD OF TRUSTEES of the VILLAGE OF FLANAGAN that the Village Code, Title XI, Chapter 111, Section 111.02 is amended as follows (language removed in ~~strike through~~, new language in ***Bold Italics***):

“§ 111.02 LICENSING.

Except to the extent licensed by the Village Board, ~~no gambling game shall be played, kept, allowed, or used on any premises licensed to serve alcohol in the village~~ ***any gambling games played, kept, allowed, or used on any premises licensed to serve alcohol in the village shall comply with video gaming regulations of the State of Illinois, including but not limited to the Video Gaming Act, 230 ILCS 40/1 et seq.***

For purposes hereof, ***GAMBLING GAME*** includes, but is not limited to, the following, when used as a wagering device: baccarat, 21, poker, craps, slot machine, video game of chance, roulette, Klondike table, punchboard, faro, keno, numbers ticket, push card, jar ticket, pull tab, and the like. It shall be unlawful for any liquor licensee, or for any officer, associate, member, representative, agent, or employee of such licensee, to permit or allow anyone to play for money, or other valuable thing, any gambling game. No gambling device shall be kept or used upon any premises licensed hereunder. Notwithstanding, video gaming terminals may be operated in accordance with the Video Gaming Act, 230 ILCS 40/1 et seq., and the regulations of the State Gaming Board promulgated thereunder, at licensed establishments, and nothing in this section shall be construed to prohibit video gaming terminals operated at licensed establishments in accordance with the Video Gaming Act.
