AN ORDINANCE GRANTING GREENVILLE LODGE #245 A  
CONDITIONAL USE TO OPERATE A CLUB OR LODGE AT 1111 E

WHEREAS, a application has been filed by Greenville Lodge #245 requesting Conditional Use permit to operate a Club or Lodge at 1111 E College, Greenville, Illinois, and,

WHEREAS, the question of granting said conditional use permit was referred to the Planning Commission of the City of Greenville to hold a public hearing thereon, and,


WHEREAS, said public hearing was duly held, after proper public notice in the manner provided by law, and,

WHEREAS, said Commission made a report containing findings of fact and recommending the granting of said amendment.

THEREFORE, BE IT ORDAINED by the City Council of the City of Greenville, of Bond County, Illinois, that a conditional use is hereby permitted to allow Greenville Lodge #245 to operate a club or lodge in a Neighborhood Urban zone at 1111 E College Avenue, Greenville, Illinois.

This ordinance shall be effective from and after its passage and approval as required by law.
