AN ORDINANCE AMENDING MUNICIPAL CODE,  
CHAPTER 95, LAKE AND RESERVOIRS OF THE CITY OF  
GREENVILLE, BOND COUNTY, ILLINOIS

BE IT ORDAINED by the Mayor and City Council of the City of Greenville, Bond County, Illinois, as follows:

WHEREAS, the Municipal Code, Chapter 95, Lake and Reservoirs, Section 95.25, Boating, (B)(1) Licenses,(i) Horsepower Restrictions shall be amended;

WHEREAS, §95.25 as previously set forth in Ordinance 2717, established Outboard and Inboard/Outboard Engine horsepower limit; and

WHEREAS, the City Council has determined that it is in the best interest of those who live and use Governor Bond Lake for recreational pursuits to modify the horsepower limit.;

IT IS HEREBY ORDAINED AND ESTABLISHED an Amendment to Chapter 95 of the Code of Ordinances as follows:

Section 95.25 Boating (B)(1) Licenses (i) Horsepower


1. Outboard engines shall have a maximum 225 horsepower limit and Inboard/Outboard engines shall have maximum 300 horsepower limit.

All prior Ordinances which are inconsistent with this Ordinance are hereby repealed.

This Ordinance shall be effective from and after its passage and approval as required by law.

Adopted this 8th day of December 8, 2015 at a regular meeting of the Mayor and City Council with a quorum present upon a vote of the City Council as follows:


