AN ORDINANCE AMENDING CHAPTER 74, SCHEDULE III OF THE MUNICIPAL CODE,
PARKING FOR PERSONS WITH DISABILITIES, IN THE CITY OF GREENVILLE, BOND COUNTY
ILLINOIS

The City Council of the City of Greenville, Bond County, Illinois, in meeting assembled, does hereby find and determine as follows:

WHEREAS, the City Council for the City of Greenville is authorized pursuant to Chapter 74, Schedule III "Parking for Persons with Disabilities" of the City of Greenville Code of Ordinance and also by Illinois Statute to designate parking spaces for persons with disabilities within the corporate limits of the City of Greenville; and

WHEREAS, the City Council has determined that it is in the best interest of the public safety of the residents of the City of Greenville to relocate a designated parking space for persons with disabilities.

WHEREAS, there currently is designated a handicap space on College Avenue just west of the alley between Second Street and Third Street.

NOW THEREFORE, let it be ordained by the Mayor and the City Council of the City of Greenville, as follows:

SECTION1 - GENERAL STATEMENT: That Chapter 74, Schedule III, of the Greenville Code is hereby amended to add the following:

Relocate the existing handicap parking space on College Avenue from its current location to the first space just West of Second Street.

SECTION 2 - EFFECTIVE DATE: This Ordinance shall be in full force and effect from and upon its passage and publication in pamphlet form as provided by law.

SECTION 3 - REPEAL: All prior Ordinances which are inconsistent with the provisions of the Ordinance are hereby repealed.

SECTION 4 - SAVINGS PROVISION: In the event any section, subsection, sentence or phrase of the Ordinance should be declared invalid, all other provision hereof shall not be affected by such invalidity and shall remain in full force and effect.
