AN ORDINANCE AMENDING CHAPTER 115: TAXICABS OF THE CITY CODE OF ORDINANCES, BY THE CITY OF GREENVILLE, BOND COUNTY, ILLINOIS

WHEREAS, it is desired that the Greenville Code of Ordinances Chapter 115: Taxicabs be amended in the following respects:

A. That portion of Section 115.10, being:

“Rates of Fare.”

Rates of fare shall be those as approved by the City Council and all fares to be charged shall be first submitted to the City Council for approval before the operation of any taxicab is begun. It shall be unlawful for a passenger to fail or refuse to pay the lawful fare at the termination of the trip.”

is hereby amended and replaced with the new Section 115.10 which will say:

“Rates of Fare.”

Rates of fare shall be those as approved by the City Manager and all fares to be charged shall be first submitted to the City Manager for approval before the operation of any taxicab is begun. It shall be unlawful for a passenger to fail or refuse to pay the lawful fare at the termination of the trip.”

B. That portion of Section 115.11 (A), being:

“Cab Stands.”

Cab stands shall be in the areas designated by the City Council by Ordinance.”

is hereby amended and replaced with the new Section 115.10 which will say:

“Cab Stands.”

Cab stands shall be in the areas designated by the City Council by Ordinance. Cab stand has been designated as City Hall Municipal Parking Lot located at 404 S Third Street”

NOW, THEREFORE, LET IT BE RESOLVED by the Mayor and the City Council of the City of Greenville, Bond County, Illinois, as follows:

SECTION 1-GENERAL STATEMENT: That effective April 28, 2016, it is desired that Chapter 115 of City Code be amended in the following respects:

A. That portion of Section 115.10, being:

“Rates of Fare.”

Rates of fare shall be those as approved by the City Council and all fares to be charged shall be first submitted to the City Council for approval before the

operation of any taxicab is begun. It shall be unlawful for a passenger to fail or refuse to pay the lawful fare at the termination of the trip.”

is hereby amended and replaced with the new Section 115.10 which will say:

“Rates of Fare.

Rates of fare shall be those as approved by the City Manager and all fares to be charged shall be first submitted to the City Manager for approval before the operation of any taxicab is begun. It shall be unlawful for a passenger to fail or refuse to pay the lawful fare at the termination of the trip.”

B. That portion of Section 115.11 (A), being:

“Cab Stands.

Cab stands shall be in the areas designated by the City Council by Ordinance.”

is hereby amended and replaced with the new Section 115.10 which will say:

“Cab Stands.

Cab stands shall be in the areas designated by the City Council by Ordinance. Cab stand has been designated as City Hall Municipal Parking Lot located at 404 S Third Street”

SECTION 2-REPEAL: All prior Ordinances and/or Resolutions, which are inconsistent with the provisions of this Ordinance are hereby repealed.

SECTION 3-SAVINGS PROVISIONS: In the event any section, subsection, sentence or phrase of this Ordinance should be declared invalid, all other provisions hereof shall not be affected by such invalidity and shall remain in full force and effect.

SECTION 4-EFFECTIVE DATE: That this Ordinance shall remain in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
