**AN ORDINANCE GRANTING BOND COUNTY MEMORIAL POST

WHEREAS, a application has been filed by Bond County Memorial Post #1377 requesting Conditional Use permit to operate a bar or tavern at 2043 S Fourth Street, Greenville, Illinois, and,

WHEREAS, the question of granting said conditional use permit was referred to the Planning Commission of the City of Greenville to hold a public hearing thereon, and,


WHEREAS, said public hearing was duly held, after proper public notice in the manner provided by law, and,

WHEREAS, said Commission made a report containing findings of fact and recommending the granting of said amendment.


