AN ORDINANCE AMENDING CHAPTER 118: LIQUOR CONTROL OF THE CITY CODE OF ORDINANCES, BY THE CITY OF GREENVILLE, BOND COUNTY, ILLINOIS

WHEREAS, it is desired that the Greenville Code of Ordinances Chapter 118: Liquor Control be amended in the following respects:

A. That portion of Section 118.20 I, being:

“(I) Class I License (Bar or Tavern)”

A Class I license shall authorize the retail sale of all varieties of alcoholic liquor for use or consumption and not for resale in any form. The local Liquor Commissioner shall issue zero type I licenses. The fee for a Class I license shall be as set at \$600. Class I licenses shall authorize the premises to be open for business from 6:00 a.m. to 1:00 a.m. on each day from Sunday through Thursday, from 6:00 a.m. to 2:00 a.m. the following day on each Friday and Saturday (Fridays at 6:00 a.m. through Saturday at 2:00 a.m., and Saturdays at 6:00 a.m. through Sunday at 2:00 a.m.). Sale of alcohol shall cease promptly at the times set forth above and shall not commence until the approved hours for the following day.”

is hereby amended and replaced with the new Section 118.20 I which will say:

“(I) Class I License (Bar or Tavern)”

A Class I license shall authorize the retail sale of all varieties of alcoholic liquor for use or consumption and not for resale in any form. The local Liquor Commissioner shall issue two type I licenses. The fee for a Class I license shall be as set at \$600. Class I licenses shall authorize the premises to be open for business from 6:00 a.m. to 1:00 a.m. on each day from Sunday through Thursday, from 6:00 a.m. to 2:00 a.m. the following day on each Friday and Saturday (Fridays at 6:00 a.m. through Saturday at 2:00 a.m., and Saturdays at 6:00 a.m. through Sunday at 2:00 a.m.). Sale of alcohol shall cease promptly at the times set forth above and shall not commence until the approved hours for the following day. “

NOW, THEREFORE, LET IT BE RESOLVED by the Mayor and the City Council of the City of Greenville, Bond County, Illinois, as follows:

SECTION 1-GENERAL STATEMENT: That effective August 18, 2016, it is desired that the City of Greenville Liquor Control Ordinance be amended in the following respects:

A. That portion of Section 118.20 I, being:

“(I) Class I License (Bar or Tavern)”

A Class I license shall authorize the retail sale of all varieties of alcoholic liquor for use or consumption and not for resale in any form. The local Liquor Commissioner shall issue two type I licenses. The fee for a Class I license shall be as set at \$600. Class I licenses shall authorize the premises to be open for business from 6:00 a.m. to 1:00 a.m. on each day from Sunday through Thursday, from 6:00 a.m. to 2:00 a.m. the following day on each Friday and Saturday (Fridays at 6:00 a.m. through Saturday at 2:00 a.m., and Saturdays at 6:00 a.m. through Sunday at 2:00 a.m.). Sale of alcohol shall cease promptly at the times set forth above and shall not commence until the approved hours for the following day..”

is hereby amended and replaced with the new Section 118.20 I which will say:

“(I) Class G License (Bar or Tavern)”

A Class I license shall authorize the retail sale of all varieties of alcoholic liquor for use or consumption and not for resale in any form. The local Liquor Commissioner shall issue two type I licenses. The fee for a Class I license shall be as set at \$600. Class I licenses shall authorize the premises to be open for business from 6:00 a.m. to 1:00 a.m. on each day from Sunday through Thursday, from 6:00 a.m. to 2:00 a.m. the following day on each Friday and Saturday (Fridays at 6:00 a.m. through Saturday at 2:00 a.m., and Saturdays at 6:00 a.m. through Sunday at 2:00 a.m.). Sale of alcohol shall cease promptly at the times set forth above and shall not commence until the approved hours for the following day. “


SECTION 2-REPEAL: All prior Ordinances and/or Resolutions, which are inconsistent with the provisions of this Ordinance are hereby repealed.

SECTION 3-SAVINGS PROVISIONS: In the event any section, subsection, sentence or phrase of this Ordinance should be declared invalid, all other provisions hereof shall not be affected by such invalidity and shall remain in full force and effect.

SECTION 4-EFFECTIVE DATE: That this Ordinance shall remain in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
